

Industry Press Releases

From HUD #24-114: HOME is the largest Federal block grant to state and local



governments for the creation of affordable housing for low-income households. HUD recently announced \$1.3 billion for fiscal year 2024 to over 650 participating jurisdictions. This notice of proposed rulemaking is the first significant update to the regulations governing the HOME program in over a decade. These up-

dates would improve the ability of participating jurisdictions who receive HOME to implement funding more effectively and efficiently – making it easier for States and localities to use HOME to support low-income renters, homeowners, and homebuyers.

From IHCDA #24-24, 24-25, 24-23: LIHTC and Federal Program income and rent limits have been published.

IHCDA is reviewing draft versions of Form A to be used for the 4% AWHTC and 9% deals. The drafts can be accessed in the 2025 QAP Forms folder <u>here</u>. The comment period has now closed. IHCDA will also be releasing an online application to be utilized for the 2025 funding rounds in July. Testing for the online application has begun with the goal of it going live by June 1, 2024.

Ralph E. Biggs & Charyl Luth Scholarship Opportunities





AHAIN is proud to support education by awarding scholarships to qualified students. Scholarships are awarded to selected qualified candidates in the amount of \$1,500 per year with potential for renewal for up to four years. To be eligible the person must be enrolled full or part time in a vocational, undergraduate, or graduate (2 or 4 year) accredited school. Additionally, the person must be a <u>current resident</u>, property employee, or direct family member of a property employee of an AHAIN member affordable housing community. AHAIN has awarded more than \$6,500 in scholarship funds in the last two years!

NEW FOR 2024: AHAIN will award a "finder's fee" of \$250 to the person who refers the selected winner of the 2024 Ralph E Biggs and Charyl Luth Scholarships.
